We at Ready Hands Home Care ("Ready Hands" or "we" or "us" or "our") appreciate your interest in this web site (the "Site"). Your privacy is important and we are committed to protecting the personally identifiable information ("Personal Information") that you disclose to us. We want you to understand our practices with respect how we gather and use the information we collect from visitors to the Site.

Information We Collect

We collect both Personal Information and non-personally identifiable information through this Site in order to help us to learn more about how our visitors use this Site, to measure areas of interest, and to provide our users with important information on our services. Collection of information allows us to build features and functionality that will enhance your experience. You are not obligated to provide us with Personal Information in order to use the Site. We collect non-personally identifiable information through the use of General Tracking Information and Click Path Tracking (cookie technology) described below.

Collection of Non-Personally Identifiable Information

General Tracking Information

We keep track of the pages visited by each user. Our web server automatically collects some information about you when you request pages from our server, including your IP address. Your IP address is a number that is used by computers connected to the Internet to identify your computer so that data (such as the web pages you request) can be sent to you. We aggregate this data with data on the pages visited by other users to track overall visitor traffic patterns. We use this information to improve our Site by making it more responsive to the needs and preferences of our users. This information does not identify you personally.

Click Path Tracking

"Cookies" are pieces of information that are placed on an individual's computer hard drive to enable the individual to more easily communicate and interact with a website. We reserve the right to use cookie technology to track your click path through our Site. Though this information does not identify you personally, we may use it to help customize your visit to our Site. We may also use cookies to record how many times a user has visited our Site and what pages the user has accessed. You may, however, disallow receiving cookies at any time through your web browser. It is not our intention to use cookies to retrieve information that is unrelated to our Site or your interaction with our Site.

Collection of Personally Identifiable Information

Collection of Personal Information

If you choose to complete the contact form on our Site, you will be asked to provide Personal Information which may include your name, mailing address, e-mail address, phone number and an explanation of your reasons for contacting us. We do not actively share Personal Information gathered from our Web servers. The purpose of the contact form is to allow you to make an inquiry about our services in a manner convenient to you. You are not required to complete the form if you are seeking information from us; you may call, write or email us at your discretion instead.

What we do with the Personal Information we Collect

We request Personal Information from you in order to learn more about your interest in our services and the nature of your needs for home care. We also need this Personal Information in order to contact you at your request. We may do this via email, telephone or regular mail depending on your expressed preferences and the nature of the contact information you provide us. We do not use this Personal Information for any other purpose, and in particular we do not share or sell your information, add your name to any contact or mailing lists or use it to send you future updates, offers, promotional materials or other correspondence.

Links to Third Party Websites

Occasionally we may include on our Site a hyperlink (a "Link") which allows you to connect to a page on a third party website ("Third Party Site"). Ready Hands provides these Links to you as a convenient method of accessing information that may be useful or of interest to you. This Privacy Policy and the practices that we follow under this Privacy Policy do not apply to Third Party Sites which are operated independently from Ready Hands. We are not responsible for the content, accuracy, or opinions expressed on any Third Party Site or for the privacy practices of any third party. We will not, and are under no obligation to, investigate, monitor or check the Third Party Sites for accuracy or completeness, or for any obscene, scandalous, inflammatory, pornographic, indecent, profane, defamatory or unlawful content or materials.
